Historically, imprisonment has been a globalized phenomenon in its techniques and politics. However, to this day, it remains almost exclusively considered from the North, where research and expertise on prisons are gathered. This international conference will discuss the circulation of prison as a form of punishment in space and time, in order to unveil the origin and genealogy of Southern prisons, as well as the production modes of a supposedly universal penitentiary model. Studying Southern prisons can in return provide a better understanding of carceral forms in the North.

We also want to question comparative analysis, in order to avoid drawing up an inventory of prisons throughout the world. Moreover, we want to avoid a performative comparison, setting the North as a model and the South as a place that should develop to follow that model.

This international conference will thus build the foundations of a comparative approach of prison from various disciplines (anthropology, geography, political science, sociology), and various institutions, with a focus on prisons in the South. Practitioners from the private sector and from NGOs will also be invited in order to better understand the circulation and local adaptation of practices.

Our research network « Economy of Prison and Punishment in Africa (ECOPPAF) that received funds from the French National Research Agency in October 2015 (Project co-ordinated by Frederic Le Marcis and Marie Morelle) will be presented, and The Prison Insider platform will be launched during the conference.
